Exhibitors agree to hold harmless the WICKED COMIC CON and any of its production partners from loss or damage of merchandise or injury sustained during attendance at its events. The WICKED COMIC CON takes no responsibility for items lost or stolen; it is up to vendors to carry insurance for their goods.</p> <p>Exhibitors will limit their display to the rented table space and a reasonable distance behind that space that is deemed "theirs" and will not alter the convention floor plan in any way. No Exhibitor will be or is allowed to have any item(s) in the aisle space of the convention floor without PRIOR approval of the authorized convention liaison.</p> <p>Exhibitors requiring electrical, phone, Internet, cable and/or other communications connections need to contact the WICKED COMIC CON prior to the show date and make the appropriate arrangements. Wi-Fi is available for free courtesy of the WESTIN BOSTON SEAPORT DISTRICT.</p> <p>Exhibitors will not bring any gambling devices (EX: grab bags, dice games, card dispensing machines etc.) to be used on or near the premises of the WICKED COMIC CON and the WESTIN BOSTON SEAPORT DISTRICT.</p> <p>Exhibitors will not and are not permitted to affix anything to the convention room walls. Any damage to the facility NOT reported to the WICKED COMIC CON and/or the WESTIN BOSTON SEAPORT DISTRICT before 10:00AM EST on the morning of the show, will completely be the responsibility of the exhibitor occupying the space; and said exhibitor will be held personally responsible for said damage.</p> <p>Due to space restrictions in dealer areas, all dealers are limited to the amount of workers/help. The limit is two (2) persons per paid table, and one (1) person per additional paid table. No exceptions. Workers/Help in found in violation will be asked to leave, unless entry fee is paid.</p> <p>The WICKED COMIC CON strictly prohibits promotion of genre events without pre-written confirmation. Although we often allow this to occur at our sole discretion, if the event you wish to promote is directly competitive to existing or planned WICKED COMIC CON events, unfortunately we cannot allow promotion of said conventions. Distribution of promotional flyers for comic book or other genre conventions without permission will result in your booth being closed without refund.</p> <p>No Exhibitor will be permitted to set up after 9:45 AM EST Saturday April 9, 2022.</p> <p>The WICKED COMIC CON has the right to remove any offensive material displayed. No nudity is to be displayed at any Exhibitor's table. Sale of weapons is strictly prohibited.</p> <p>The tables you purchase are for your consumption ONLY. NO SUBLETTING and OR RESELLING of tables is allowed.</p> <p>The WICKED COMIC CON only allows the sale of licensed merchandise (including videotapes) at its events. Exhibitors are responsible for the legality of the items they sell, as well as government and/or tax licenses, and insurance.
