Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend and hold harmless the WICKED COMIC CON and all their employees and agents against all claims and damages to person or property, governmental charges and or fines and attorney fees arising out of or caused by exhibitor's installation, removal, occupancy or use of the exhibition premises any part thereof. Exhibitors agree to hold harmless the WICKED COMIC CON and any of its production partners from loss or damage of merchandise or injury sustained attendance at its even The WICKED COMIC CON takes no responsibility for items lost or stolen; it is up to exhibitors to carry insurance for their goods.
2. Exhibitors will limit their display to the rented table space and a reasonable distance behind that space that is deemed "theirs" and will not alter the convention floor plan in any way. NO Exhibitor will be allowed to have any item(s) in the aisle space of the convention floor without PRIOR approval of the authorized convention liaison.
3. Exhibitors requiring electrical, phone, Internet, cable and/or other communications connections need to contact WICKED COMIC CON prior to the show date and make the appropriate arrangements.
4. Exhibitors will abide by the rules and regulations of the event venue.
5. WICKED COMIC CON has the right to remove any offensive material displayed in its sole and absolute discretion. The sale of weapons is strictly prohibited. The tables you purchase are for your consumption ONLY. NO SUBLETTING and OR RESELLING of tables is allowed.
6. WICKED COMIC CON only allows the sale of licensed merchandise at its events. Exhibitors are responsible for the legality of the items they sell, as well as government and/or tax licenses, insurance.
